ABSTRACT

We provide an overview of recent limit theorems involving non-linear functionals of Gaussian- or Poisson-based stochastic processes. These results have proven useful e.g. in the study of power variations associated with fractional processes, as well as of other limit objects that may be relevant in financial modeling.
